Trump Rule Threatens New Mexico Waters

The Trump Environmental Protection Agency (EPA) and the Army Corps of Engineers have released the anticipated change to the rule that defines what waters are protected by the federal Clean Water Act. The revised “Waters of the United States” (WOTUS) rule will exclude from protection all “ephemeral” bodies of water that flow with variable volume and sometimes go dry.

These changes will be devastating for New Mexico!

Because of our highly variable snow-pack melts and occasional bursts of rain, New Mexico is rich in ephemeral flows. These include precious wetlands,

streams and small rivers - including the Santa Fe, Gallinas, San Fernando, and Tijeras. Many streams and wetlands on Tribal lands would also lose Clean Water Act protections.

Unlike federal rollbacks in areas of environmental protection that affect other natural resources, our vulnerable waters do not have any state protections to fall back on. New Mexico is one of just three states that does not have delegated authority from the EPA to regulate our waters.

We rely on the EPA to protect our surface waters. But the revised rule does not meet the mandate of the Clean Water Act to protect the interests of the public who rely on clean water for drinking, agriculture, recreation, and simple aesthetics.

In September, the Law Center, with our client Amigos Bravos, [submitted comments](#) on the proposed change that outline the risks to New Mexico waters if the rule went through. The final rule is somewhat different from the proposed rule and we will review it closely. We and our clients have the option to challenge the ruling in federal District Court.
