STIPULATED ORDER

THIS MATTER having come before the Court on Defendant Charles Wagner's Motion to Enforce Subpoena, and the Court having reviewed the Motion, FINDS the Deputy State Director of LULAC has failed to obey Defendant's subpoena and failed to provide an adequate excuse for the failure to obey the subpoena.
