If Mr. Kortemeler will agree to stipulate to our Motions for Stay and for Protective Order, then

However as long as the current deadlines remain in place, and as long as Mr. Wagner continues to improperly hamper Cooperative meetings, to make public statements in violation of his fiduciary duty to the Cooperative, and to refuse to use trial discovery to seek information from the Cooperative, we cannot agree to any further delay. These issues need to be before the Court as quickly as possible.

Given the humber and complexity of the Motions to be considered at that hearing, I believe we all have a duty to the Court to insure that briefing is completed as early as possible.

While I understand that Mr. Ikard has been ill, Ms. Selinger has not. I am centain that she and her firm have addressed these issues before, and that they will be able to complete their Responses within the regularly established deadlines.

Please let me know how you would like to proceed.


