Descriptions for New District Boundaries

District 1

Beginning at a point where the township line between T5N and T6N intersects the line between R4W and R5W; thence east along line dividing T5N and T6N to the point of intersection with the New Mexico Principal Meridian; then south along the New Mexico Principal Meridian to the County line dividing Valencia and Socorro Counties; thence easterly along the north boundary of Socorro County to the Rio Grande; thence north along the east bank of the Rio Grande to a point where New Mexico Hwy 304 crosses the Santa Fe Railroad at Madron; thence southeast along the Santa Fe Railroad to the boundary line between the Tome Grant and the Casa Colorado Grant; thence east along the south boundary of the Tome Grant line to the County line Between Valencia and Torrance Counties; thence southerly along the Valencia-Torrance County line to the southwest corner of Sec. 15, T1N, R5E; thence east to the point of intersection with 106° -20' west longitude; thence south to the point of intersection with the township line dividing T1S and T2S; thence west along line dividing T1S and T2S to a point where said line intersects with the range the line dividing R3W and R4W; thence north along the line dividing R3W and R4W to a point where said line intersects with the range the line dividing R4W and R5W; thence north along the township line dividing R4W and R5W to the point of beginning.

District 2

Beginning at the northwest corner of the Socorro Grant then east along the northern boundary of the Socorro Grant to the northeast corner of the Socorro Grant; thence south along the east boundary of the Socorro Grant boundary to the point of intersection with 34° 3'42.45" N latitude; thence west along 34° 3'42.45" N latitude to the point where said line meets Otero Street; thence continue west along the south boundary of Otero Street crossing California Street to the south boundary of San Miguel Street; thence continue west along the south boundary of San Miguel Street to the point of intersection with Bernard Street; thence south along the east boundary of Bernard Street to the point of intersection with Terry Street; thence west along the south boundary of School of Mines Rd to the point of intersection with Leroy Place; thence west crossing Leroy Place to Navajo; thence west along the south boundary of Navajo to the point of intersection with Olive Lane; thence northerly along west boundary of Olive Lane to the point of intersection with Canyon Rd; thence west along 34° 4'0"N latitude to the point of intersection with the west boundary of the Socorro Grant; thence north along the west boundary of the Socorro Grant to the point of beginning.

District 3

Beginning at the intersection of 34° 4'0"N latitude and the west boundary of the Socorro Grant; thence east along 34° 4'0"N latitude to the point of intersection with Canyon Rd; thence east along the south boundary of Canyon Rd to the point of intersection with Olive Lane; thence southerly along the west boundary of Olive Lane to the point of intersection with Navajo; thence east along the south boundary of Navajo to the point of intersection with Leroy Place; thence east crossing Leroy Place to the point of intersection with School of Mines Rd.; thence southeasterly along the south boundary of School of Mines Rd. to the point of intersection with Terry Street; thence east along the south boundary of Terry Street to the point of intersection with Bernard Street; thence north along the east boundary of Bernard Street to the point of intersection with San Miguel Street; thence east along the south boundary of Otero Street to the point where said line meets 34° 3'42.45" N latitude; thence east along 34° 3'42.45" N latitude to the point of intersection with the east boundary of the Socorro Grant; thence south along the east boundary of the Socorro Grant to the southeast corner of the Socorro Grant; thence west along the south boundary of the Socorro Grant to the southwest corner of the Socorro Grant; thence north along the west boundary of the Socorro Grant to the place of beginning.

District 4

Beginning at a point where the range line dividing R8W and R9W intersects the township line dividing T5N and T6N thence east along the township line dividing T5N and T6N to a point where said line intersects with the range line dividing R4W and R5W; thence south along the line dividing R4W and R5W to a point where said line intersects the township line dividing T1N and T1S; thence east along line dividing T1N and T1S to a point where said line intersects with the range line dividing R3W and R4W; thence south along the line dividing R3W and R4W to a point where said line intersects the township line dividing T1S and T2S; thence east along line dividing T1S and T2S to a point where said line intersects with the range line dividing R6E and R7E; thence south along the line dividing R6E and R7E to a point where said line intersects the township line dividing T3S and T4S; thence east along line dividing T3S and T4S to the county line between Socorro and Lincoln Counties; thence south along the Socorro-Lincoln County line to a point where said line intersects the township line dividing T5S and T6S; thence west along line dividing T5S and T6S to a point where said line intersects with the range line dividing R8E and R9E; thence south along the line dividing R8E and R9E to a point where said line intersects the township line dividing T7S and T8S; thence west along line dividing T7S and T8S to a point where said line intersects with the range line dividing R5E and R6E; thence south along the line dividing R5E and R6E to a point where said line intersects the township line dividing T11S and T12S; thence west along line dividing T11S and T12S to a point where said line intersects the New Mexico Principal Meridian; thence north along the New Mexico Principal Meridian to a point where the New Mexico Principal Meridian intersects the Southern boundary of Socorro County; thence west along the Southern boundary of Socorro County to a point where said boundary intersects with the range line dividing R6W and R7W; thence north along the line dividing R6W and R7W to a point where said line intersects the township line dividing T1N and T1S; thence east along line dividing T1N and T1S to a point where said line intersects with the range line dividing R7W and R8W; thence north along the line dividing R7W and R8W to a point where said line intersects the township line dividing T2N and T3N; thence east along line dividing T2N and T3N to a point where said line intersects with the range line dividing R8W and R9W; thence north along the line dividing R8W and R9W to the place of beginning; excluding any part of the Socorro Grant.

District 5

Beginning at a point on the New Mexico- Arizona state boundary where said boundary is intersected by the southern boundary of the Zuni Indian Reservation thence easterly along the southern boundary of the Zuni Indian Reservation to a point where said boundary intersects the township line dividing T8N and T9N; thence east along line dividing T8N and T9N to a point where said line intersects with range line dividing R12W and R13W; thence south along the line dividing R12W and R13W to a point where said line intersects with township line dividing T5N and T6N; thence east along line dividing T5N and T6N to a point where said line intersects the range line dividing R8W and R9W; thence south along the line dividing R8W and R9W to a point where said line intersects the township line dividing T2N and T3N; thence east along line dividing T2N and T3N to a point where said line intersects with range line dividing R7W and R8W; thence south along the line dividing R7W and R8W to a point where said line intersects the township line dividing T1N and T1S; thence east along line dividing T1N and T1S to a point where said line intersects with range line dividing R6W and R7W; thence south along the line dividing R6W and R7W to a point where said line intersects the township line dividing T9S and T10S; thence west along the line dividing T9S and T10S to a point where said line intersects with range line dividing R8W and R9W; thence south along the line dividing R8W and R9W to a point where said line intersects the township line dividing T10S and T11S; thence west along line dividing T10S and T11S to a point where said line intersects with range line dividing R17W and R18W; thence north along the line dividing R17W and R18W to a point where said line intersects the township line dividing T6S and T7S; thence east along the line dividing T6S and T7S to a point where said line intersects with range line dividing R15W and R16W and also the southwestern most corner of the Quemado School District boundary; thence northerly along the Quemado School District and Reserve Independent School District to a point where said line intersects the township line dividing T3S and T4S; thence west along the line dividing T3S and T4S to the New Mexico-Arizona State Boundary; thence north along the New Mexico-Arizona boundary to the point of beginning.
