## **DOCKETING ORDER**

This matter came before Uday V. Joshi, the Managing Attorney of the State Engineer's Hearing Unit, upon a Request for Pre-Hearing Scheduling Conference (Request), filed on February 2, 2017. Having reviewed the Request, the Managing Attorney of the Hearing Unit finds that a docketing order should be issued and hearing fees should be submitted prior to the issuance of a Scheduling Order. A Pre-Hearing Scheduling Conference (PHSC) is tentatively scheduled for July 19, 2017. The Hearing Unit will issue advance Notice of PHSC indicating the time and location.

The parties are advised that the above-captioned matter has been docketed as Hearing No. 17-005. Pursuant to NMSA 1978, Section 72-2-6(J) and 19.25.2.10 NMAC, the Applicant must submit a \$25.00 hearing fee for the application; and, each Protestant must submit a \$25.00 hearing fee.

Protestants who protested this application are encouraged to form a group and obtain legal representation. Pursuant to 19.25.2.11 NMAC, "[a] party that is not an individual shall be represented by an Attorney" (emphasis added). Certain Protestants may be considered, upon a Motion to Consolidate Protestants, as a single protesting party. Each protesting party will be required to submit one hearing fee (\$25) and will have a single right of appeal. Parties who previously paid hearing fees in 2010 for Hearing No. 09-096, do not need to send a hearing fee for this Corrected Application.
