FACT SHEET

What is the Santolina Master Plan?

- The Santolina Master Plan is a proposed development that would cover 13,850 acres on the Southwest Mesa
- The Santolina Master Plan proposes 38,000 houses, plus commercial and industrial buildings to be built on unstable sand dunes
- The developers project an estimated population of 95,000 people; that is more than the 2010 population of Rio Rancho – and the third largest city in New Mexico

QUESTIONS: 1) Where would the water for this development come from and 2) Who would pay for it?

Why is this development a bad idea? Because Santolina would:

- Increase taxes for all residents within the Albuquerque Metro Area
- Require infrastructure costs that would cause a loss of tax dollars to all other areas of our communities
- Increase the 'overbuilt housing' glut, depressing property values countywide
- Providing water service outside of the established area would cost an estimated \$100 million for new infrastructure; currently the Water Authority has over \$380 Million in maintenance backlogs
- Santolina would increase transportation costs the plan is projecting two interstate exchanges, at \$30 million each
- It would also increase the tax burden over \$1 billion for schools, roads, and other infrastructure
- Santolina poses increased negative health impacts related to the increased exposure to blowing sand resulting from the disturbance of ancient geologic sand dunes

FACT: Santolina would directly affect urban growth, future taxes, water use, and the economic and environmental well being of all the people in the Albuquerque Metro area. Where will the money come from to pay for this? It would come from raising YOUR taxes!

How will it affect current water availability?

- It would deplete the underground water in the Rio Grande Basin which is likely irreversible
- Santolina projects to ultimately need nearly 20 million gallons of water per day, or ~22,400 acre feet per year
- The San Juan Chama water is already completely allocated; Santolina would require the purchase of senior water rights to supply the need from farmers within the Rio Grande Basin and necessitate a steep increase in groundwater pumping
- The wells in the North and South Valleys would be de-watered by the demands for water needed by this massive development
